This includes the services of arranging, and tying flower bouquets together, arranging, and tying together boutonnieres, pins for boutonnieres, arranging, and tying together corsages, wristlets for corsages and basket for flower girl, (if chosen). This is agreed upon by both parties: Kerschner Creations and customer: \_\_\_\_\_. Pictures of final products are required of Kerschner Creations, and any advertising of final products by client is allowed, with mention of 'Kerschner Creations' with website attached: \_\_\_\_\_
- If by any reason, this agreement is not able to be completed, by acts of nature or God, sickness, or events beyond the control of the parties or due to Kerschner Creations illness or injury, then Kerschner Creations will reimburse all fees to client but will have no other liability with this agreement.
- A \$100 no refundable fee is required to save your wedding date with Kerschner Creations. Will be put towards whole fee due.
- A 2/3 deposit is due at signage on this contract, flower reimbursement due upon invoice to client (through email) and balance of fees due once arrangements received by client. This deposit is non-refundable in the event of cancellation or date change. When deposit is given - wedding date must be at least 5 weeks away
- Amount agreed upon covers Kerschner Creations' time, and efforts. This amount cannot be changed or altered by any means.
- It is understood that Kerschner Creations will complete the job to their utmost abilities and produce wonderfully beautiful products for their client.
- Charges in this contract are based upon Kerschner Creations current prices at time of consultation and can be adjusted by Kerschner Creations periodically. Future orders will be charged at prices in effect at time of consultation.
- Shipping is offered instead of pickup at a fee based on shipping rates. \*\*\*subject to change\*\*\*
- Purchase of flowers are not included in regular fees. Customer is responsible for the purchase of flowers: \_\_\_\_\_
- Real flowers will be bought in bulk, and when possible, will be from local flower farms.
- Silk flowers used for weddings will be bought at Hobby Lobby, Michaels, and/or Joann Fabrics. (unless otherwise agreed upon)
- Customer is responsible for flower reimbursement once invoice is emailed to them. A budget can be set, and Kerschner Creations will be cautious about said budget
